RESOLUTION NO. PL 60-07

RESOLUTION OF THE PYRAMID LAKE PAIUTE TRIBE OF THE PYRAMID LAKE INDIAN RESERVATION NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. section 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe pursuant to Article VI, Section 1 (i) and (j) of the Constitution of the Tribe and Article V of the Bylaws of the Tribe, adopted the Pyramid Lake Tribe's Fishing, Boating and Camping Regulations; and
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the following amendments to the Fishing, Boating and Camping Regulations for the Pyramid Lake Paiute Tribe:
 - "1.19 GUIDE: Any person(s) engaged in the business to manage, supervise, conduct, direct, lead, steer, escort, pilot, show, control, affect, influence, or regulate, another person(s) in sport fishing for monetary gain."
 - "7.2.3 Cui-ui fishing is closed (Endangered Species)."

"Section 9: GUIDE LICENSE REQUIREMENT. 9.6 RULES AND REGULATION FOR FISHING SERVICES.

- 9.6.1 All person(s) guiding fishing must complete a Pyramid Lake Paiute Tribal Guide Application available at the Pyramid Lake Paiute Tribal Offices located at 208 Capitol Hill, Nixon, Nevada.
- 9.6.2 All applications must receive prior approval by the Pyramid Lake Tribal Council. All application fees are applicable and must be paid in full at time of permit. The annual fee shall be \$500.00 per guide.
- 9.6.3 All guides must be bonded and insured. A background check will be required to be completed by the guide and submitted to the Pyramid Lake Paiute Tribe with the application. All rules on guide permit apply.
- 9.6.4 Person(s) guiding within the exterior boundaries of the Pyramid Lake Indian reservation, without a current and valid Tribal Council Guiding License may result in the revocation of all fishing and boating permits issued by the Pyramid Lake Paiute Tribe, and up to but not limited to five (5) years and subject to fines set forth in the appearance bond schedule.
- 9.6.5 Guide Services cannot use another guide services
 Tribal License or (guide) permit. There is only one
 person per guide permit and the permit is nontransferable. "

"FISHING BOND SCHEDULE.

9.6 Operating Fishing Guide Services without Tribal approval - \$2,000.00"

"Section 9 – LICENSE REQUIREMENTS.

9.1 Non-Tribal Members. All non-Tribal members, except as set forth at Section 9.3 below, twelve (12) years and older must have in their possession a valid Tribal Fishing Permit to fish in the open waters within the exterior boundaries of the Reservation. Non-Tribal members under twelve (12) years can fish at no charge with an adult who possesses a current valid Tribal fishing permit.

"BOATING REGULATIONS. SECTION 1: DEFINITIONS.

1.15 CHARTER. A person(s) or franchise granted permission by the Pyramid Lake Paiute Tribal Council to lease or hire for exclusive use that can be leased or hired for exclusive or private use, a tour, vacation, or trip by charter arrangement a vehicle or water vessel with or without a guide."

"BOATING REGULATIONS. SECTION 3: BOATING EQUIPMENT (Applies to Non-Tribal Members).

- 3.1.7 CERTIFICATE OF NUMBER. Vessels under 16 feet and 16 through 40 feet in length. All undocumented vessels equipped with propulsion machinery must be State registered. Certificate of Number must be on board when vessel is in use.
- 3.1.8 STATE NUMBERING. State numbering must be plain block letters and numbers not less than three inches in height, must be affixed on each side of the forward half of the vessel (contrasting color to boat exterior). State validation sticker must be affixed within six inches of the registration number. Decal must be current and not expired.
- 3.1.9 CERTIFICATE OF DOCUMENTATION. Documented vessels must have original and current certificate on board. Vessel name or hailing port must be marked on exterior part of hull letters not less than 4 inches in height. Official number must be permanently affixed on interior structure not less than 3 inches in height (Vessels less than 16 feet not required)."

"CAMPING REGULATIONS. 11.5.1 PERMITS REQUIRED (Applies to Non-Tribal members)

The beaches on the East side of the Lake (Pyramid Lake Beach/Stone Mother) are designated for day use only. Long Beach and the Sutcliffe Marina Beach are designated for family beach use only (No Alcohol). Illegal drug use is prohibited on the Pyramid Lake Indian Reservation."

"CAMPING REGULATIONS. 11.7 ANIMAL CONTROL

11.7.5 It is unlawful to tamper with animal control devices."

"11.11 PROPERTY DEFACEMENT:

11.11.3 No Non-Tribal member shall be allowed to use a metal detector within the exterior boundaries of the Pyramid Lake Indian Reservation. Federal ARPA laws apply."

"SECTION 13 PERSONAL WATERCRAFT (Applies to Non-Tribal members).

- 13.9 CERTIFICATE OF NUMBER: Vessels under 16 feet and 16 through 40 feet in length. All undocumented vessels equipped with propulsion machinery must be State registered. Certificate of Number must be on board when vessel is in use.
- 13.10 STATE NUMBERING. State numbering must be plain block letters and numbers not less than three inches in height, must be affixed on each side of the forward half of the vessel (contrasting color to boat exterior). State validation sticker must be affixed within six inches of the registration number. Decal must be current and not expired.
- 13.11 DOCUMENTED VESSELS. Documented vessels must have original and current certificate on board. Vessel name or hailing port marked on exterior part of hull letters not less than 4 inches in height. Official number permanently affixed on interior structure not less than 3 inches in height (Vessels less than 16 feet not required)."

"SECTION 13. WATERCRAFT BOND SCHEDULE.

13.9 FAILURE TO COMPLY WITH CERTIFICATE NUMBER \$100.00

13.10 FAILURE TO COMPLY WITH STATE NUMBERING \$100.00

13.11 FAILURE TO COMPLY WITH CERTIFICATE OF DOCUMENTATION \$100.00"

"SECTION 13. FISHING DERBIES.

- 1.1. PERMITS, RULES AND FEES:
- 1.1.1 All fishing derbies and special fishing events must submit a letter of request and application form to the Pyramid Lake Tribal Council for approval prior to holding the event.
- 1.1.2 Upon approval an event fee will be assessed by the Pyramid Lake Paiute Tribe based upon information provided to Tribal Finance office.
- 1.1.3 A \$10.00 Special Fishing Permit Fee per person per event to be paid by the host, promoter, organization (person in charge, organizer) and is due before the event starts. Valid Pyramid Lake Paiute Tribal fishing and boating permits are still required.
- 1.1.4 Organizer of derby/event is responsible for re-imbursement to Tribe for Search and Rescue if negligence on part of the participant is determined.
- 1.1.5 All Creel Census data is to be strictly adhered to.
- 1.1.6 Failure to comply with rules and regulations shall result in civil fines set forth in the Fishing Bond Schedule, Section 12.1 Enforcement.
- 1.1.7 Maximum length of derby/event is two (2) days.
- 1.1.8 Derby/event organizer must be bonded and insured. Certifications of coverage shall be submitted to the Tribe with the derby/event application."

"FISHING REGULATION. SECTION 3. ILLEGAL TACKLE.

3.1.2 Only one combination of rod, line and not more than two hooks (as defined in section 1.6 above) which hooks shall be barb less, shall be used by one person at a time and equipment shall be closely attended by such person while fishing."

"FISHING REGULATION. SECTION 4. FISHING SEASON.

4.1 FISHING SEASON. Due to spawning season the open waters of Pyramid Lake shall be open to fishing year round, with the exception of Trout Season, which shall be open from October 1 to June 30 of each year. From March 15 to May 16, closed areas are from the Sutcliffe Marina up to and including the South Nets Beach area. Fishing within 500 feet of all boat docks is prohibited."

"BOATING REGULATIONS. SECTION 9: BOAT RENTALS. 9.4 RULES AND REGULATIONS FOR CHARTER AND GUIDE SERVCIES.

- 9.4.1 Charter and guide (boat) must fill out a Tribal Charter or Guide (boat) application, available upon request at the Pyramid Lake Tribal Offices in Nixon, Nevada. The annual fee shall be \$3,000.00 per boat and 5% of sales
- 9.4.2 The application is subject to approval by the Pyramid Lake Paiute Tribal Council.
- 9.4.3 Charter (guide boat services) must be bonded and insured and shall be subject to a background check.
- 9.4.4 The approved applicants cannot use another Charter's (guide boat service) license or Tribal permit which is non-transferable.
- 9.4.5 Charter (guide boat service) without a Tribal Permit shall result in loss of Tribal fishing and boating privileges from the Pyramid Lake Indian Reservation for up to a period of three years, and shall be subject to fines set forth in the Boating Appearance Bond Schedule (Up to \$5,000.00 civil fine).", and

BE IT FINALLY RESOLVED, that these amendments shall become effective upon adoption by the Pyramid Lake Paiute Tribal Council.
